Bylaw 02-2024

Being a Bylaw to appoint Officers and Confirm Salaries

BEING a bylaw for the purpose of appointing officers and confirming salaries for a period from November 15, 2022 to November 30, 2026.

WHEREAS the Municipal Act maintains that the council of a municipality may pay remuneration to the members of council.

AND WHEREAS the Municipal Act maintains that the council of a municipality may provide by bylaw for paying in whole or part such expenses of the members of council and of officers and servants of the municipality as are actually incurred as a result of their capacity as members of council or officers of the municipality and as authorized by bylaw.


